## Exhibitor Badges

**Exhibitor badges will only be issued to employees of exhibiting firms.** Nurses who register for CEU credit at NTI will receive Participant Badges. In order to process exhibitor registrations in a timely manner, exhibitor pre-registration is imperative.

Each representative of an exhibiting company must wear the official AACN badge at all times while in the exhibit area. Supplementing this identification with business cards or company badges is not permitted. Exhibitor badges may be made out only in the name of the company shown on the application for exhibit space.

**Each exhibiting company is allowed to register FIVE booth personnel per 10' x 10' booth space. (Example: A 20' x 20' island contains 4 - 10' x 10' units; 5 individuals per 10' x 10' booth spaces = 20 registered individuals.)**

All badges will be distributed on-site only and may be picked up at the Exhibitor Registration Desk.

## Guests of Exhibitors

Every effort will be made to assure that only properly identified and authorized registrants enter the exhibit areas. Each exhibiting company will be mailed **10 guest invitations/VIP passes**, regardless of the size of the exhibitor's booth. Requests for additional invitations may be made in writing to the AACN Exhibits Department. Guest badges allow admittance to the exhibits only.

The exhibitor is responsible for determining that guests who are nurses should be registered through the AACN registration procedures to receive CE credit for educational sessions and should NOT obtain VIP passes. Misuse of the exhibitor guest badge system may result in the expulsion of the exhibitor and guest from the exhibit hall and is considered a violation of the NTI Rules and Regulations.
