Dear Chairwoman Foxx and Ranking Member McGovern:

On behalf of the 54 undersigned organizations representing the Nursing Community Coalition (NCC), we urge you to accept amendment 103 during the Rules Committee's hearing on H.R.8800, the National Defense Authorization Act for Fiscal Year 2027. This amendment is offered by Chairman Walberg and Representatives Courtney and Kiggans, and is based on H.R.3170, the Improving Access to Workers' Compensation for Injured Federal Workers Act. The NCC is a cross section of education, practice, research, and regulation within the nursing profession, representing Registered Nurses (RNs), Advanced Practice Registered Nurses (APRNs),<sup>1</sup> nurse leaders, boards of nursing, students, faculty, and researchers. Together, the NCC supports this amendment.

Amendment 103 is a no cost solution which will retire outdated barriers in the Federal Employees' Compensation Act (FECA) that limit the ability of nurse practitioners (NPs) to diagnose and oversee the care and treatment of federal employees, including Department of Defense civilian employees, Civil Air Patrol volunteers, and Reserve Officer Training Corps (ROTC) cadets, who are injured or become ill in the course of their employment. Additionally, this amendment includes report language specific to reviewing FECA claims for DOD civilians. Retiring these barriers will ensure our nation's federal employees, including DOD civilians, have timely access to care when injured on the job.

Currently, federal employees can select an NP as their health care provider under the Federal Employees Health Benefits (FEHB) Program. However, contrary to the workers' compensation process in the majority of states, FECA requires that only a physician can make the diagnosis, certify the injury and extent of the disability, and oversee the patient's treatment and care. This barrier places an additional burden on the over 700,000 DOD civilians and other federal employees, depriving them from receiving health care from their provider of choice, as well as hindering timely access to care and continuity of care.<sup>2</sup>

This amendment would update FECA and authorize NPs to certify disabilities and oversee treatment for injured or ill federal employees. This would improve access to health care for injured or ill federal employees, particularly in rural and underserved communities, and align the federal workers' compensation program with state law. Updating FECA to authorize federal employees to select their health care provider of choice when they are injured or become ill in the course of their federal employment ensures greater access, improves efficiency, and provides continuity of care.
